FINANCIAL REPORT:

• Carla Conrardy presented the unaudited statement of financial position for the nine months ending April 30, 2020. *Detailed financial information can be found in the Board Meeting packets, which are posted to the Foothills Gateway website.*

OLD BUSINESS:

 MOU between FGI and the Foothills Gateway Foundation – Mark shared the MOU that has been updated following legal consultation. Mark explained the addition to the MOU and invited questions/discussion.

M-S-C (Katz/Zimmerman) Accept the new MOU between Foothills Gateway Inc. and the Foothills Gateway Foundation as circulated on May 19th 2020.

NEW BUSINESS:

• **FY20-21 State Budget Information** – Erin shared the information from the State Budget, Punkie asked how CFCM plans are being impacted. Erin shared that this is unknown at present though the decision to combine IDD Case Management and Single Entry Point Case Management along with combining all the HCBS Waivers has been delayed for at least another year. Erin shared that the pandemic will also affect Mill Levy funding, and this was discussed.

EXECUTIVE TEAM UPDATES:

- Erin Eulenfeld COVID19 Update: Erin shared that under the Safer at Home order effective May 4th, FGI can increase number of staff in the building up to 50%. Staff are entering the building at a specific time each day, and the Executive Team is performing health screenings. Building reopening will happen slowly as state orders are modified. HCPF has provided stringent direction to CCB's and PASA's about how services are to be provided at this time. Transportation is only allowed on a 1:1 basis and social distancing (must be six feet apart) must occur in the vehicle. Services can be provided but only with masks and whilst maintaining social distance. Day Program can only have 10 people total (staff and persons with IDD) together in the FGI building. No physical support or personal care can be provided. Symptom and temperature checking will also have to be done on Individuals. Acquiring Personal Protective Equipment (PPE) equipment has also been problematic. Erin has been listening to calls with government and health agencies to stay on top of information relating to the pandemic. Mikel asked when the next PCT Coaches and Leaders meeting will be occurring. Debbie L said the April Leader's Meeting and May PCT Council meetings have been cancelled, and the next Leaders meeting is currently scheduled for July. Mark offered the Board's support and assistance should FGI need it.
- **Debbie Klein:** The CCB designation for the coming year has been received.
- **Debbie Lapp:** Debbie L has been working with Pat and Marla on plans for the next year.

COMMITTEE REPORTS:

<u>Executive Committee</u> – Mark shared that the Executive Committee met on April 10th, 2020 and discussed the Board Meeting Agenda, COVID 19 Update, Nancy Kepner training question, FGI's Agency Calendar for FY20-21 and the Executive Team Updates given above.

<u>Fiscal and Property Committee</u> — Mark Durand shared that the Fiscal and Property Committee met prior to this meeting and discussed the YTD April Financial Statement, Investments and FSSP Waitlist — Funding information
