# **OFFICER UPDATES**

#### Erin Eulenfeld

- CMRD Update HCPF held a meeting last week to provide an overview of Myers and Stauffer's (CPA firm) work on case management time studies and costs in order to develop a case management rate methodology for CMAs. Currently, the full report is being reviewed by HCPF and is expected to be released in early December. Linda asked how familiar Myers and Stauffer is with the type of work we do. Erin shared their history with our system which extends 15 or more years. Alliance will be supporting the CCB's in analyzing the information from the report. Also, HCPF contracted with HMA to provide coaching and technical assistance to case management agencies for CMRD related transition activities. HCPF suspended the HMA support/technical assistance in mid-October until after the RFP has closed.
- CARF The CARF Survey was completed in October. Erin explained the process and which agency departments were involved in the survey process. Erin also shared that CARF had no recommendations for program improvement during this survey cycle. Board members requested that the CARF survey report be shared with media outlets, state departments, and on social media.
- Rep Hugh McKean Erin shared that the memorial for Rep McKean was held last
   Thursday at the state capitol, and the funeral was last Saturday. Erin further shared
